Non-Competitive/Touring membership

This Application Form is for Non-Competitive/Touring membership of the Irish Veteran Cyclists Association. On this form, you may opt for basic (non-cycling) membership or Non-Competitive cycling membership (i.e. touring, leisure). Personal Accident Insurance is compulsory for participation in any IVCA cycling event.

A separate Racing Application Form should be used if you wish to apply for Racing Membership.

Terms and Conditions for IVCA membership

1. Membership of the IVCA is subject to approval by the Directors and to the Constitution of the Company.
2. Personal Accident Insurance is compulsory for participation in any IVCA cycling event and an approved cycling helmet must be worn. Cycling Ireland's insurance policy does not currently provide cover for IVCA events.
3. Members 66 of age and over with 10 years' unbroken membership of the IVCA immediately prior to the current year's application are entitled to free membership and racing fees (where appropriate). However, members qualifying for free membership must pay for Personal Accident insurance to participate in racing or touring events.
4. Non-racing members are entitled to free entry to the Wicklow 200/100 event on 11th June 2018, which forms part of the IVCA Leisure League.
5. A valid e-mail address must be provided for the purposes of official communications from the Company (e.g. notifications of AGM or other events). If you do not have an e-mail address, a family member or friend may be willing to allow you to use theirs.
